#### Federal and State Law

Federal law requires each state to have a license sanction procedure for individuals who owe back child support.

Under Kansas law, if you are behind in paying your court-ordered child support, you can be denied the purchase of a recreational license.

#### **Denial of Licenses**

The Kansas Department for Children and Families (DCF) has identified you as not being current in your child support payments.

This information has been provided to the Department of Wildlife, Parks and Tourism. At this time, the Department of Wildlife, Parks and Tourism is required to deny the sale of a recreational license.

#### This includes:

- Hunting Licenses, Stamps, Tags;
- Fishing Licenses;
- Trapping Licenses;
- Boating Permits;
- Park and Camping Fees; or
- Other issues of the Department of Wildlife, Parks and Tourism.

#### **Corrective Action**

In order to resolve this issue and receive a recreational license, you may take one of the following steps:

- Pay in full all past due child support
- Make a voluntary unscheduled payment of \$500 to automatically release the denial
- Make a voluntary unscheduled payment of \$250 per court case number on a case-by-case basis.

If you believe you are current in your support payments, or you have already taken one of the above steps, contact the Child Support Call Center at 1-888-757-2445.

Staff can review your case to determine the accuracy of the information reported to the Department of Wildlife, Parks and Tourism.

#### **Appeal**

If you disagree with the decision made by DCF, you have the right to request an administrative hearing.

You may request a fair hearing by sending a written request to your local Child Support Services office.
