What qualifies as a Unconventional Vehicle?

Vehicle classes which qualify for the unconventional vehicle permit are work site utility vehicles including UTV's (Utility Terrain Vehicle) and low-speed vehicles including golf carts.

*ATV's (all-terrain vehicle), such as fourwheelers, <u>DO NOT</u> qualify and cannot receive one of these permits.

Properly registered, tagged and equipped mopeds qualify for purchase of a regular motor vehicle permit not the unconventional vehicle permit.

Permit?


Unconventional Vehicle Permits are only sold in Kansas Department of Wildlife and Park Offices.

When is my permit valid?

Permits are valid for the calendar year in which they are purchased.

How should my permit be displayed?

Permits must be attached to the front driver's side of the vehicle for which the permit was purchased and they must be easily visible.

Does my Unconventional Vehicle need to have a Kansas Tag or be insured?

Unconventional Vehicles in Kansas State Parks do NOT require a State Issued Kansas License Plate.

Kansas State Parks do not require proof of insurance. However, it is the responsibility of the unconventional vehicle owner to provide adequate insurance for use of that vehicle in this manner.

Who can drive my

<u>Unconventional Vehicle in the Kansas State park?</u>

All operators must possess a

valid driver's license.

All speed limit and alcohol statutes are applicable to unconventional vehicles.

No Open Alcohol Containers are allowed while in motion

If you Drink- DON'T DRIVE



Where am I allowed to drive my Unconventional Vehicle?

The Unconventional Vehicle Permit is valid ONLY in Kansas State Parks.

Unconventional Vehicles are **NOT**

allowed in the Wildlife Area

Permitted Unconventional Vehicle may only be operated on state park roadways posted with a 30 mile per hour or less speed limit.

No off-road use is allowed.

Unconventional Vehicles are
PROHIBITED from operation on state highways. Unconventional vehicles may CROSS a state highway incidental to their operation.

All occupants in the
Unconventional Vehicle must
be seated in a manufacturers
equipped seat when the
vehicle is in motion
