Creel Clerk – Clinton Reservoir:

Kansas Department of Wildlife and Parks – Fisheries Division is seeking two part-time creel clerks to conduct in-person interviews of anglers at Clinton Reservoir. The position will run from March 1, 2026 to February 28, 2027. The position will be directly supervised by Jim Miazga, Fisheries Biologist, and is based out of the Clinton Wildlife Area Office, near Stull, KS.

The primary goal of this position is to communicate with anglers to understand their behaviors, preferences, levels of satisfaction, catch, and harvest. These data will provide important information for evaluating fishery performance and informing management strategies.

Successful applicants must be comfortable speaking to the public and able to identify common fish species. Applicants will need a flexible schedule as days worked will include both weekdays and weekends. Shifts will typically be 4 to 8 hours per day. Hours per month will vary from 48 to 80 hours. A state-owned vehicle will be provided.

BENEFITS: Starting pay rate of \$15.03/hr., depending on experience and length of commitment.

MINIMUM REQUIREMENTS: Must have a valid motor vehicle operator's license; must be a minimum of 18 years of age; able to work with minimal supervision; must be able to communicate in a calm and effective manner with members of the public in all conditions. Preference will be given to those graduated or currently enrolled in a natural resource degree, or those having a high interest in biology, conservation, or environmental science.
