Seasonal Position – Woodson Wildlife Area

Two temporary positions are available (999 hours max.) at the Woodson Wildlife Area, Yates Center, KS, and are directly supervised by Connor Rolen, Public Lands Manager. This position is for the 2026 season. The individuals will be involved in all aspects of Wildlife and Parks Public Lands operations. Job duties include but are not limited to; Preparing food plots for planting, wetland management, prescribed burning, tree removal, timber stand improvement, control of noxious weeds and other undesired vegetation, assisting in cattle grazing operation, and parking lots and grounds maintenance. Operation of a variety of equipment including tractors and agricultural implements, (discing, mowing, planting food plots, etc.), track skid loaders, UTV's with mounted sprayers, riding mowers, and 1-Ton trucks pulling trailers. Knowledge of equipment operation and maintenance is highly preferred but not required. Incumbents will work a maximum of 40 hours per week. Positions will run through the spring and summer months and into the fall. Start and end dates are negotiable.

BENEFITS: Hourly wage \$15.03 – \$17.00 per hour depending on experience, education, and abilities. Normal work week will be Monday-Friday, 20 to 40 hours per week, 999 hours per calendar year. No paid holidays.

MINIMUM REQUIREMENTS: Must be self-motivated, dependable, physically fit and able to perform demanding tasks in a variety of outdoor settings and weather conditions. Required to be at least 18 years of age with a valid driver's license. A preference will be given to students working toward a natural resources' degree.
