SMARSH CREEK GROUP CAMPGROUND

Cheney State Park offers a campground that may be reserved for family reunions, company celebrations, and similar group gatherings.

Vehicle permits are required on all vehicles.

Groups pay for the exclusive use of the campground rather than the number of sites. Individual utility sites are limited to one camper per site. Additional primitive camping may be allowed by approval from park staff.

GROUP SITES OFFER THE FOLLOWING AMENITIES:

20-,30-, 50-amp electric and water sites.

A picnic table and fire ring at each site.

A group shelter with a barbecue grill, picnic tables, and a restroom located nearby.

A shower house nearby at Smarsh Creek Camp Ground.

The group campground must be reserved at least 14 days in advance.

Fees for the group campground must be paid in advance for all days reserved.

Reservations will be taken up to one year in advance.

There will be a \$25 non-refundable reservation fee.

If the group campground is not rented, anyone can reserve the shelter house. The earliest it can be reserved is 13 days prior to the day or days of use.



CANCELLATIONS

Cancellations may be made up to 30 days in advance for a full refund. If cancellations are made within the 30-day period, \$50 will be forfeited, plus the \$25 reservation fee.

There is a 3-day minimum reservation on holiday weekends.
